WHY IS BENTLEY DISCONTINUING SUPPORT FOR POWERDRAFT?

Infrastructure design and project requirements are evolving. MicroStation and Bentley's Open Modeling Environment provide the capabilities needed to win business and drive better project outcomes (e.g., 3D modeling, BIM deliverables, and photorealistic visualizations). PowerDraft does not. While 2D workflows remain crucial, more and more they must be optimized and automated to meet the increasing requirements for efficiencies in infrastructure projects.

MicroStation has stood the test of time and is now used by 90% of the ENR top 250 engineering firms. Its DGN file format is the gold standard for infrastructure design, now trusted by leading infrastructure owner-operators. Users of MicroStation are well-positioned to capitalize on modern infrastructure projects. They transition easily between it, BIM OpenModeling applications, and digital twins to support evolving project requirements with common user interfaces and seamless file interoperability. 2. Uninstall PowerDraft using your organization's software deployment process.
3. Install MicroStation using your organization's software deployment process.

Yes, due to the nature of the stable DGN file format, you will have complete business continuity across your body of work originating from PowerDraft.

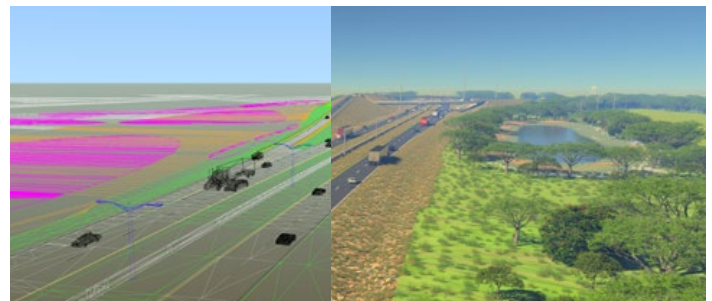
DO I NEED TO TRAIN POWERDRAFT USERS TO PERFORM 2D WORKFLOWS IN MICROSTATION?

No, users of PowerDraft will be perfectly at home with MicroStation and will experience no user interface challenges.

MicroStation users can transition easily to BIM OpenModeling applications and digital twins to support evolving project requirements with common user interfaces and seamless file interoperability, unlike the competition. Some of the things you can do with MicroStation are:

WILL POWERDRAFT BE SUPPORTED?

PowerDraft will move **effective immediately** to Full Support from Continuous Support as defined in the [Bentley Desktop Application Support Policy](#). It will move to Expiring Support status beginning **December 31, 2022** and then to Support Discontinued status beginning **December 31, 2023**.

WILL THERE BE FUTURE UPDATES TO POWERDRAFT?

All new enhancements and fixes to 2D infrastructure drawing capabilities will be implemented within MicroStation. From time to time, while in Full Support, security and non-security maintenance updates may be released.

IF I OPT-OUT OF TRANSITIONING TO MICROSTATION, CAN I CONTINUE TO RUN POWERDRAFT?

Yes; however, see the question regarding support. Once PowerDraft has transitioned to Support Discontinued status, PowerDraft will record usage as MicroStation.

WHEN I TRANSITION MY LICENSES FROM POWERDRAFT TO MICROSTATION AND STILL USE POWERDRAFT, WILL I BE CHARGED FOR A TERM LICENSE?

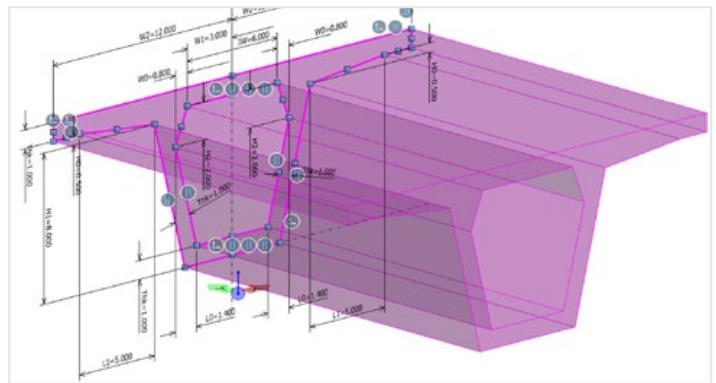
During the quarter you transition and the subsequent quarter, term licenses for both PowerDraft and MicroStation will be suppressed. This means during that time period, you would not be charged a term license. After this period, yes, a PowerDraft term license will be generated.
